**Explanation of Responses:**

- 1,500 common units of limited partnership interest ("Common Units") in Easterly Government Properties LP (the "Partnership"), of which the Issuer is the sole general partner, were redeemed for an equal number of shares of the Issuer's common stock, par value \$0.01 per share ("Common Stock").
- The sale was effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person through Easterly Capital LLC, an entity controlled by the Reporting Person, on March 12, 2021.
- Represents the weighted average sale price per share. These shares were sold in multiple transactions at prices ranging from \$22.10 to \$22.33 per share, inclusive. The reporting person undertakes to provide upon request by the U.S. Securities and Exchange Commission staff, the Issuer or a security holder of the Issuer, full information regarding the number of shares sold at each separate price.
- Each Common Unit may be presented for redemption, at the election of the holder, for cash equal to the fair market value of a share of the Issuer's Common Stock, except that the Issuer may elect to acquire each Common Unit so presented for one share of Common Stock. These redemption rights have no expiration date.
